BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to San Diego Municipal Code section 22.0101, Rule 1, the regular meetings of the City Council scheduled on Monday, October 3, 1988 and Tuesday, October 4, 1988 be and the same are hereby cancelled due to an anticipated lack of a quorum of City Councilmembers because of official City business out of the city.

BE IT FURTHER RESOLVED, that the City Clerk be and he is hereby directed to post and publish appropriate notice of the cancellation of the above specified meetings.
