WHEREAS, it has been deemed necessary to engage in appropriate activities to analyze and prepare documentary control over land use around the Lindbergh Field area; and


WHEREAS, such action is required to assure a clear and hazard free approach zone to the airport; and

BE IT RESOLVED, by the Council of The City of San Diego, that the City Attorney be and he is hereby authorized to seek outside specialized legal counsel for advice and legal consultant service, as necessary, regarding the eastern approach zone to Lindbergh Field.

BE IT FURTHER RESOLVED, that the City Attorney is requested to bring to the Council, for approval, an agreement regarding such consultant services at the time such outside consultant is selected.
