ADOPTED ON SEP 26 1988

WHEREAS, the Ninth District PTA administers and funds a Health and Welfare grant program that allowed over 12,000 children the opportunity to learn about drug awareness, AIDS education, self-esteem, alcohol abuse, and child abuse; and

WHEREAS, the Ninth District PTA funds and identifies children for free dental care program focusing on preventative dental care in addition to maintenance dental care for all children requiring such care; and

WHEREAS, the Ninth District PTA distributes shoes to needy children throughout the county although few people know that it is a California State law that children must have on shoes to enter school; and

WHEREAS, the Ninth District PTA partners an academic decathlon with the San Diego County Board of Education oriented to the secondary level and provides opportunities for recognition for students, and the schools from which they hail; and

WHEREAS, the Ninth District PTA directs the Hug-A-Tree program which is a kindergarten through third grade safety program with emphasis on teaching the children strategies to be used during times of natural disaster; and

WHEREAS, the Ninth District PTA facilitates a national PTA arts program called "Reflections" which encourages member PTAs to submit literary, artistic, and photographic contributions for publication in the PTA's national magazine, Reflections; and

WHEREAS, the Ninth District PTA orchestrates another child safety program specifically designed for "latch key children;" and

WHEREAS, the Ninth District PTA has provided over 3 million volunteer hours in pursuit and support of the programs for children; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of all the people of San Diego, does hereby commend the Ninth District PTA for its role and function in the community of San Diego and also extends its sincerest expression of gratitude to the many volunteers donating hours of effort for its programs.

BE IT FURTHER RESOLVED, that the month of October be and is hereby proclaimed to be "Ninth District PTA Month" in San Diego.
