WHEREAS, the 1988 Beijing World Baseball Tournament was hosted by the People's Republic of China from August 15 to August 21, 1988; and

WHEREAS, the United States was represented in the tournament by teams from Los Angeles, San Diego, and Colorado; and

WHEREAS, San Diego's team was named the "San Diego Stars"; and

WHEREAS, the San Diego Stars Baseball Team was comprised of 11- and 12-year old All Stars from local Little League, Pony League, and Bronco League teams; and

WHEREAS, the San Diego Stars won the 1988 Beijing World Baseball Tournament by defeating each of the six teams they faced including: the Philippine National Team, two teams from Beijing, the Japanese National Team, and the teams from Los Angeles and Colorado; and

WHEREAS, members of the San Diego Stars conducted themselves as excellent ambassadors for San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of all of the citizens of San Diego, does hereby recognize the accomplishments of the San Diego Stars and commends them for their tournament championship.

BE IT FURTHER RESOLVED, that Monday, September 26, 1988, be  
and the same is hereby designated as "San Diego Stars  
Appreciation Day" in San Diego.
