RAILROAD); \$8,500 from Gas Tax Fund 30219, CIP No. 52-328.0 FRIARS ROAD MEDIAN BARRIER AND TRAFFIC SIGNAL - SAN DIEGO STADIUM; and \$60,000 from Gas Tax Fund 30219, CIP No. 52-328.2 FRIARS ROAD MEDIAN BARRIER - MISSION CENTER ROAD TO RIVER RUN DRIVE to CIP No. 52-110.2 BEYER BOULEVARD - ROUTE 117 TO NORTH CITY LIMIT.
