BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$86,403 from CIP No. 22-050.4 MISSION BAY WATER QUALITY is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in CIP No. 22-050.4 MISSION BAY WATER QUALITY.

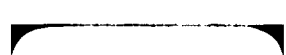
