APPROVING MAP OF MESA CLASSIC - UNIT 2.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That said Council hereby finds that certain map surveyed by William Gregory Clarke, Licensed Land Surveyor, entitled "MESA CLASSIC - UNIT 2 being a subdivision of a portion of Government Lot 4 in Section 2, Township 15 South, Range 3 West, San Bernardino Meridian, according to official plat thereof and a portion of Parcel 3 of Parcel Map No. 13071, filed in the office of the County Recorder of San Diego County of December 23, 1983, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Keoki Court, Kamwood Street and Dancy Road, and said streets are hereby declared to be public streets, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Flanders Street, adjacent and contiguous to Lots 182 and 183, all as shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and those certain abutters' rights of access, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
