RESOLUTION NUMBER R- 271963

APPROVING MAP OF TIERRASANTA NORTE II, UNIT
NO. 4.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "TIERRASANTA NORTE II UNIT NO. 4 being a subdivision of a portion of Parcel 4 of Parcel Map No. 14737, in the City of San Diego, County of San Diego, State of California, according to map thereof filed in the Office of the County Recorder of San Diego County, March 20, 1987, together with portions of Via Valarta and Antigua Boulevard as dedicated to public use, and together with the drainage easement shown as Parcel E of deed recorded September 16, 1981 as File/Page No. 81-295933, Book 1981 of official records, abandoned in accordance with Section 66499.20 1/2 of the Subdivision Map Act," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Camino Playa De Oro, Camino Playa Corona, Camino Playa Azteca, and Corte Playa Madera, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Via Valarta, adjacent and contiguous to Lots 330, 331, 352, 353, 371 and 372; in and to Antigua Boulevard, adjacent and contiguous to Lots 372 through 382 and 386, all as shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, all as granted and shown on the map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
