ADOPTED ON SEP 26 1988

WHEREAS, the existing Conflict of Interest Code for the office of the City Clerk was adopted by Resolution No. R-220260 on February 9, 1978, and amended by Resolution No. R-265851 on June 2, 1986; and

WHEREAS, by Ordinance No. O-17081 adopted on April 25, 1988, the City Council approved the creation of the unclassified position of Deputy Director in the office of the City Clerk; and

WHEREAS, the creation of the Deputy Director position necessitates amending Exhibit A of the existing Conflict of Interest Code to add the position to the list of designated employees obliged to disclose reportable financial interests; and

WHEREAS, the creation of the Deputy Director position also necessitates amending Exhibit B of the existing Conflict of Interest Code to describe those types of financial interests that should be disclosed by the designated employees of the office of the City Clerk; and

WHEREAS, both Exhibits A and B of the existing Conflict of Interest Code have been amended to reflect the above-described changes necessitated by the creation of the position of Deputy Director in the office of the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Conflict of Interest Code of the office of the City Clerk as amended by Resolution No. R-265851 adopted on June 2, 1986, be and is hereby amended by amending Exhibits A and B thereto as shown on the attached copies.
