<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Susan Levine	Communications & Electrical	\$745.74	Ms. Levine is a Communications Technician. She suggested repairing instead of replacing the clutch assembly in dictaphones. This has resulted in an estimated savings of \$2,485.80. This is a partial award pending a 12-month review.
Robin Glenn	Risk Management	\$387.71	Ms. Glenn was an Intermediate Typist at the time of this suggestion. She suggested using the SAS Computer System to input rehabilitation notes. This has resulted in a savings of \$2,862.75. This is the remainder of her award.
Dennis Marnell	General Services	\$160.00	Mr. Marnell is an Equipment Mechanic with the Equipment Division. He suggested the installation of a 1/4" steel plate in place of 14 gage steel plates on control valves of the crane able packers. Although savings are difficult to identify, this was considered to be a significant improvement.
Donald Phillips	Manager's	\$130.00	Ms. Phillips is a Stadium Maintenance Supervisor with Jack Murphy Stadium. He suggested building television camera stands at the stadium. This has resulted in a savings of \$1,300. This is his full award.
