WHEREAS, on July 1, 1988, the County of San Diego dissolved its Lighting Maintenance Districts No. 1 and No. 3 and formed a new assessment district, the San Diego County Street Lighting District, which covers only the unincorporated area of the County; and

WHEREAS, the dissolution of said districts is not required to be reviewed and approved by the Local Agency Formation Commission; and

WHEREAS, a portion of The City of San Diego was in Lighting
Maintenance District No. 1 and continues to generate property tax
revenue for the District; and

WHEREAS, the Revenue and Taxation Code 99(c) requires the acceptance, by resolution, of the negotiated exchange of property tax revenues by all affected agencies; and

WHEREAS, the Board of Supervisors has negotiated with The City of San Diego an equitable exchange of property tax revenues applicable to such jurisdictional exchange; and

WHEREAS, property tax revenue generated for the District by properties located within the City should be transferred to The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the transfer of property tax revenue from the dissolved San Diego County Lighting Maintenance District No.1 to The City of San Diego for those properties which lie within the City be and it is hereby approved.

BE IT FURTHER RESOLVED, that the Clerk of the Board of Supervisors shall, on behalf of The City of San Diego, notify the County Auditor and the Local Agency Formation Commission of such negotiated exchange of property tax revenues by forwarding to them a copy of this resolution.
