RESOLUTION NUMBER R- 271992

ADOPTED ON SEP 26 1988

WHEREAS, City Manager's Report No. 88-436, dated August 31, 1988, relating to Transient Occupancy Tax Rates and Allocations was considered and approved by the Rules Committee on September 7, 1988 and forwarded to the full Council for approval; and

WHEREAS, recommendations approved therein relate to the financing of Balboa Park improvements which were supported by a majority of the voters in the November 1987 general obligation bond ballot proposition; and

WHEREAS, Attachment A to City Manager Report No. 88-436, a report from the Transient Occupancy Tax Allocation Committee, contains the recommendation to allocate funds sufficient to permit the City to design and construct approximately \$45 million of improvements between fiscal years 1990 and 1994; and

WHEREAS, this can be accomplished by using annual revenue and debt financing, as set forth in attachments to said City Manager Report No. 88-436; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation of the City Manager, set forth in Report No. 88-436 and attachments thereto dated August 31, 1988, to finance \$45 million of improvements to Balboa Park between fiscal years 1990 and 1994, to be funded by debt financing and annual revenues

equivalent to approximately one percent Transit Occupancy Tax, be  
and the same is hereby approved.
