

RESOLUTION NUMBER R-271993

ADOPTED ON SEPTEMBER 26, 1988

WHEREAS, at the direction of the Rules Committee, a Transient Occupancy Tax Allocation Committee was appointed by the Mayor and City Manager to consider an additional Transient Occupancy Tax increase for fiscal year 1990; and

WHEREAS, the recommendations of said Committee, attached as Attachment A to City Manager Report No. 88-436, dated August 31, 1988, include an increase in the Transient Occupancy Tax (TOT) from 8% to 9% effective June 1, 1989, with proceeds to be deposited in the City's General Fund for general government purposes; and

WHEREAS, the recommendations also include maintaining said 9% tax for at least five years (through FY 1994), limiting future increases in the TOT to a rate that is no greater than the average of fifteen major cities, and allocating the funds to the programs and projects detailed in the Committee report; and

WHEREAS, the Rules Committee on September 7, 1988 approved the Manager's Report No. 88-436 with the attached Transient Occupancy Tax Allocation Committee report; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendations of the Transient Occupancy Tax Allocation Committee, as attached to and incorporated in City Manager Report No. 88-436, and approved by the Rules Committee on September 7, 1988 be and the same are hereby accepted and approved, except as

modified from five to three years, said recommendations as amended, set forth as follows:

1. Increase the Transient Occupancy Tax from 8% to 9% effective June 1, 1989, with the proceeds deposited in the General Fund for general government purposes.


2. Promulgate and approve a policy statement which would, at future City Council discretion:

(a) Maintain the Transient Occupancy Tax at 9% for at least the next three years;

(b) Limit future increases in the tax to a rate that is no greater than the average of fifteen major cities;

(c) Allocate funds to programs and projects as detailed in the Transient Occupancy Tax Allocation Committee report.
