ADOPTED ON SEP 26 1988

WHEREAS, Pacific Bell has led private industry in providing informational and other services regarding AIDS in the workplace since 1983; and

WHEREAS, in 1985, Pacific Bell donated \$7,000 to the University of California Medical Center in San Francisco to print two editions of "A Resource Manual for Persons with AIDS" and

WHEREAS, Pacific Bell's weekly employee newspaper "UPDATE" regularly addresses AIDS issues and promoted AIDS Awareness Month in October of 1987; and

WHEREAS, Pacific Bell has sponsored the production of several informational videotapes such as "An Epidemic of Fear: AIDS in the Workplace", "AIDS: A Community Response", and "Talking to Your Family About AIDS"; and

WHEREAS, Pacific Bell has contributed and helped raise over \$300,000 to assist awareness and aid programs; and

WHEREAS, Pacific Bell has sponsored a myriad of educational programs including seminars, publications, and employee outreach; and


WHEREAS, Pacific Bell donated a computer to the AIDS Assistance Fund to allow them to track patients and records more efficiently; NOW, THEREFORE,
