RESOLUTION NUMBER R-272011

ADOPTED ON SEPTEMBER 26, 1988

WHEREAS, the Council allocated in non-Departmental Expenditures (601) a sum of \$2 million for specified uses; and

WHEREAS, the Council further amended the San Diego Municipal Code to increase the Transient Occupancy Tax by one percent (from 8% to 9%) to provide additional funds for said specified purposes; and


WHEREAS, at the September 26, 1988 Council meeting when the above actions, in addition to others relating to the same or similar matter, were considered, it was directed that a portion of said funds be allocated for funding a Freedom Arts Festival and to refer the matter to the Arts Commission for recommendation of an appropriate plan with bona fide organizations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby directed to set aside and allocate the sum of \$30,000 (equivalent to one percent of the proposed art/cultural budget) for funding a Freedom Arts Festival.

BE IT FURTHER RESOLVED, that the matter of a Freedom Arts Festival be and it is hereby referred to the Arts Commission with

directions to come back to the Council with recommendations for an appropriate plan with bona fide organizations.
