
ADOPTED ON SEP 27 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with REGIONAL ENVIRONMENTAL CONSULTANTS (RECON), for professional consultant services to provide environmental work required for the completion of the Metropolitan Sewerage System EIR/EIS, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 272024.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,199,541.00 from CIP No. 46-147.0 "Modified Wastewater Treatment Facilities Plan," Sewer Revenue Fund (41506), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
