BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for SLURRY SEAL COATING OF VARIOUS CITY STREETS GROUP "6".

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,386,877 from Gas Tax Fund NO. 30219 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
