BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF SEWER AND WATER MAIN REPLACEMENT GROUP NO. 71, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on OCT 10 1988, and bearing official Document No.

W.O. 170461/180361, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SEWER AND WATER MAIN REPLACEMENT GROUP NO. 71.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$2,322,367 (\$1,897,433 from Sewer Revenue Fund 41506 Sewer Construction Outlay 70492, CIP No. 44-001 ANNUAL ALLOCATION - MAIN REPLACEMENTS and \$424,934 from Water Revenue Fund 41502 Water Construction Outlay 70592, CIP No. 73-083 ANNUAL ALLOCATION - MAIN REPLACEMENTS) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
