WHEREAS, the Public Facilities and Recreation Committee, at its September 14, 1988, meeting, unanimously approved action in respect to funding of bikeways within the City of San Diego; and

WHEREAS, the action is exempt pursuant to Section 15061(b)(1) of the State CEQA Guidelines; and

WHEREAS, it is now requested that the matter be forwarded to the full Council for action in accordance with the unanimous recommendation of the Public Facilities and Recreation Committee; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the C.I.P. Project No. 58-047.0 entitled "Tecolote Canyon Bikeway" be and the same is hereby deleted from the Capital Improvements Program.

2. That the Auditor and Comptroller be and he is hereby authorized to reallocate the funds associated with C.I.P. No. 58-047.0, deleted by action above, back to SANDAG with the request of Council that the funds be preserved for a bikeway project within the City of San Diego.

3. That, in connection with the request of Council stated above, there be effected sufficient coordination of the design of a bikeway path in the community with the proposed Trolley station.
