
RESOLUTION NUMBER R- 272253

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a 13-month lease agreement with CAS GALLERIA, a California general partnership, for the use of 630 square feet of office space at 739 Fifth Avenue for a police storefront office, at a monthly rental of \$550, including utilities, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 272253.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$6,600 from the General Fund for lease costs from July 1, 1988, through June 30, 1989, is hereby authorized and approved.
