WHEREAS, Resolution No. R-269450 adopted October 12, 1987, authorized the City Manager to execute an agreement with the Equitable Life Insurance Society of the United States, to provide employee group life insurance, for a period of one (1.00) year, beginning July 1, 1987 through June 30, 1988, under the terms and conditions set forth in Group Insurance Policy No. 56960,D, on file in the office of the City Clerk as Document No. RR-269450; and

WHEREAS, the Group Insurance Policy guaranteed the rates for the plan of benefits underwritten for a period of three years conditional upon the transfer to EQUICOR of the premium stabilization reserved released by Pacific Guardian Life; and


WHEREAS, the premium stabilization reserve released by Pacific Guardian Life has been received by EQUICOR thereby guaranteeing such rates until July 1, 1990; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to extend, for and on behalf of said City, the agreement with the **EQUITABLE LIFE ASSURANCE SOCIETY OF THE UNITED STATES**, to provide employee group life insurance, for a period of one (1.00) year beginning July 1, 1988 through June 30, 1989, under the terms and

conditions set forth in the agreements on file in the office of
the City Clerk as Documents No. RR-269450 and No. RR- 272054.
