WHEREAS, Crime Stoppers is a volunteer nonprofit organization of concerned citizens and law enforcement officials; and

WHEREAS, Crime Stoppers allows citizens to anonymously call and report criminal activity, or information about a crime that has occurred; and

WHEREAS, Crime Stoppers has been credited with solving 830 felony cases, leading to 340 arrests with a conviction rate of 98%; and

WHEREAS, Crime Stoppers has provided information leading to the arrest of over 30 Top Ten Fugitives; and


WHEREAS, Crime Stoppers has led to the recovery of \$5 million in stolen property and narcotics; and
