ADOPTED ON OCTOBER 10, 1988

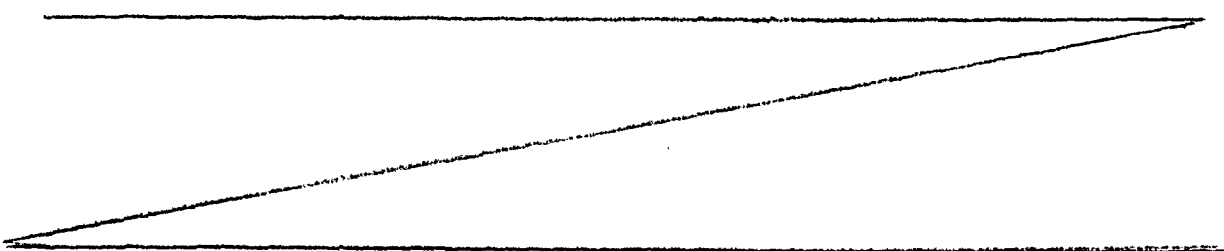
WHEREAS, the November 8, 1988 State General Election Ballot includes twenty-nine (29) statewide propositions; and

WHEREAS, said statewide propositions are numbered consecutively as Propositions 78 through 106; and

WHEREAS, summaries and recommendations for each of the propositions have been provided by The City of San Diego Intergovernmental Relations Department in its IRD Report No. 88-31, dated September 16, 1988; and

WHEREAS, the Rules Committee reviewed the various propositions at its meeting of September 21, 1988 and determined to make recommendations to the full Council on the propositions; and

WHEREAS, the Rules Committee now forwards the matter to the full Council with a recommendation that the Council support Propositions 80, 81, 82, 83, 84, 85, 86, 96, and 99, oppose Propositions 90, 98, and 102, and take no position on the remaining measures as summarized in IRD Report No. 88-33; NOW, THEREFORE,



BE IT RESOLVED, by the Council of The City of San Diego, that for the November 8, 1988 State General Election Ballot, the City Council supports Propositions 80, 81, 82, 83, 84, 85, 86, 93, and 99; opposes Propositions 90, 96, 98, and 102; takes no position on Propositions 78, 79, 87, 88, 89, 91, 92, 94, 95, 97, and 105; and defers for two (2) weeks action on Propositions 100, 101, 103, 104 and 106.
