Barbara Elam	General Services	\$1,519.83	Ms. Elam was an Account Clerk at the time of this suggestion. She suggested simplifying the procedure for reconciling the daily charges at the Miramar landfill. Actual savings of \$5,066.10 in time has been realized. This is her full award.
Ricardo McAfee Richard Long Donald Reed	General Services	\$1,464.00	Mr. McAfee is a Sanitation Driver II, Mr. Long is a Utility Worker II, and Mr. Reed is a Sanitation Driver I with the Refuse Collection Division. They suggested repairing damaged concrete litter containers. This is expected to save \$9,761.40 in materials and labor. This is a partial award pending a 12-month review.
