Vincent DeLeva	General Services	\$1,351.50	Mr. DeLeva is an Electrician Supervisor with the Communications and Electrical Division. He suggested converting existing lighting in the City College "B" Street tunnel to low sodium lighting. Actual savings of \$12,333 in energy has been realized. This is the remainder of his award.
Michael Gomez	Risk Management	\$ 870.95	Mr. Gomez is a Claims Representative II in the Liability Division. He suggested the City issue a notice of "Force Entry" to occupant or homeowner. Actual savings of \$8,709.52 in reduced paid claims against the City has been realized. This is his full award.
