Jerry White	Water Utilities	\$450.00	Mr. White is a Senior Drafting Aide in the Engineering Division. He suggested utilizing a computer program at the Hydrology Desk. This is expected to save \$3,005 in time. This is a partial award pending a 12-month review.
Josephine Gussa	Water Utilities	\$160.00	Ms. Gussa was a Word Processor Operator at the time of this suggestion. She suggested indicating the retention period for word processing materials. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Andrew Chavez	Water Utilities	\$160.00	Mr. Chavez is an Equipment Technician I. He suggested installing platforms in the Meter Shop to alleviate physical problems resulting from standing on concrete. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Gary Payne	Water Utilities	\$ 80.00	Mr. Payne is an Electronics Technician. He suggested changing the shape of speed bumps. Although savings are difficult to identify, this was considered to be a significant operational improvement.
