WHEREAS, the Civil Air Patrol is the official United States Air Force Auxiliary; and

WHEREAS, the Civil Air Patrol conducts over 80% of all land-based search and rescue operations in this country, often at great risk of its pilots; and

WHEREAS, the Civil Air Patrol provides a broad range of other emergency services operations at the national, state, and local levels including disaster damage assessment flights, customs surveillance missions, live human organ transport flights, and radiological monitoring; and

WHEREAS, in the past year alone, over 136 lives have been saved by the Civil Air Patrol; and

WHEREAS, the Civil Air Patrol has a national, voluntary membership of over 70,000, and its California Wing numbers 6,000 members in 110 squadrons; and

WHEREAS, the recent activities of Squadron No. 127, based at Brown Field, received 6 out of 12 awards given at the California Wing Awards Banquet held September 11, 1988, including: "Senior Squadron of the Year", "Senior Member of the Year", "Public Affairs Officer of the Year", "Newsletter of the Year" as well as the Commander's Commendation Medal to two of its senior officers;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does hereby commend Civil Air Patrol Senior Squadron No. 127 for its unprecedented performance in capturing six major awards by the California Wing of the Civil Air Patrol.
