WHEREAS, the people of California under the California Wildlife, Coastal and Park Land Conservation Act of 1988 has authorized the establishment of a History and Archeology Grant Program, providing funds to the political subdivisions of the State and to non-profit organizations for the preservation of significant historical and archeological resources; and

WHEREAS, the Office of Historic Preservation is responsible for the administration of the program within the State, setting up necessary rules and procedures governing application by local agencies under the program; and


WHEREAS, said adopted procedures established by the Office of Historic Preservation require the applicant to certify by resolution the approval of applications prior to submission of said applications to the State; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to submit applications to California State Department of Parks and Recreation for History and Archeology Grant Program for Marston House and San Dieguito River Valley Archeology Site Projects, in accordance with the grant application form which is on file in the office of the City Clerk as Document No. RR- 272156.

BE IT FURTHER RESOLVED, that the City Manager, or his representative, be and he is hereby authorized to perform all necessary acts to secure the funds.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to establish a fund which will earn its own interest if the grant is funded.
