That the second low bid of \$2,125,520 by EVH INC. & ASSOCIATES, a partnership, meeting specifications for CONSTRUCTION OF FIRE DEPARTMENT COMMUNICATIONS BUILDING, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 118620.

2. That the expenditure, not to exceed \$192,800 from CIP No. 33-069 FIRE DEPARTMENT SUPPORT SERVICES COMPLEX to supplement funds previously authorized by Resolution No. 271076, adopted on May 31, 1988, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
