WHEREAS, the Foundation proposes to donate funds to be used in the employment of the interior design services of Eloise DeLong Ltd./Walter Broderick Interiors and to make such purchases and donations of furniture, furnishings and equipment as are deemed necessary in excess of the City's currently budgeted funds for the project; and


WHEREAS, while the amount is as yet undetermined, the gift will be significantly in excess of \$5,000 and will fully cover the services of and purchases by Eloise DeLong Ltd./Walter Broderick Interiors for said project; and

WHEREAS, R.P. Foundation, Inc. will make funds available to the City on an incremental basis, timely to the progress of the project and the necessary payment of Ms. De Long; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to Council Policy 100-2, the City Manager is hereby authorized to accept the donation by the R.P. Foundation, Inc., in an amount in excess of \$5,000, to cover the services and

purchases of Eloise DeLong Ltd./Walter Broderick Interiors in the refurbishing of the Mayor's office and reception, conference, kitchen and administrative spaces on the eleventh floor of the City Administration Building.
