WHEREAS, the City Manager is conducting studies in respect to the control of crime and nuisances in various areas of the City; and

WHEREAS, one of the areas of extreme concern to the law enforcement agencies is the Mission Beach area in which criminal activity has been deemed prevalent and existing; and

WHEREAS, certain measures are deemed appropriate as interim emergency actions to address the health and safety of the community pending a final report by the Manager to the City Council; and

WHEREAS, the matter of closing parking lots in the Mission Beach area was discussed at the Public Facilities & Recreation Committee on October 12, 1988 and approved unanimously; NOW, THEREFORE,

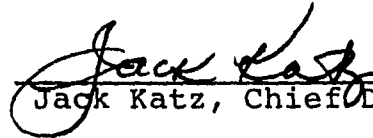
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized to close, on an emergency basis, the Mission Point and Jetty parking lots in Mission Beach from 8:00 p.m. to 5:00 a.m., pending a report from the City Manager in December, 1988 regarding the effectiveness of such closing, as well as other alternatives, to control crime and nuisance in the area.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to install clear and appropriate signage of said

closures are placed in effect.
