PROPERTY AND EASEMENTS AND TAKING IMMEDIATE POSSESSION THEREOF:

WHEREAS, the Council of The City of San Diego has provided notice to those persons designated in Section 1245.235, Code of Civil Procedure and also has provided all persons a reasonable opportunity to appear and be heard on the matters referred to in Section 1240.030, Code of Civil Procedure; and

WHEREAS, the City of San Diego desires to acquire the property hereinafter described for the construction, operation, and maintenance of a public street or streets and incidents thereto together with earth excavations or embankments, slope or slopes and incidents thereto and a storm drain or drains and incidents thereto in a portion of Parcels 1 and 2 of Parcel Map No. 11933, filed in the office of the County Recorder of San Diego County, January 29, 1982, as File No. 82-26480 of the Official Records; a portion of Pueblo Lot 1109 of Pueblo Lands of San Diego according to the map made by James Pascoe in 1870 and filed in the recorders office November 14, 1921 as Miscellaneous Map No. 36 and in a portion of Lot 2 of Lion Mission Valley No. 3 according to Map No. 10292 filed December 18, 1981; and a portion of Parcels 1 and 2 of Parcel Map No. 13432 filed on August 17, 1984 with the San Diego County Recorder, all in the City of San Diego, County of San Diego, State of California as more particularly described hereinafter; and

WHEREAS, it is in the public interest and necessity to acquire the subject real property as hereinafter described for the purpose of the construction, operation and maintenance of a public street or streets and incidents thereto together with earth excavations or embankments, slope or slopes and incidents thereto and a storm drain or drains and incidents thereto;

Section 2. That the public interest, convenience and necessity of the City of San Diego, and the inhabitants of the City of San Diego, demand the acquisition and taking of fee title to and easements in said property for the construction, operation and maintenance of a public street or streets and incidents thereto, together with earth excavations or embankments, slope or slopes and incidents thereto and a storm drain or drains and incidents thereto; said real property lying within the City of San Diego, County of San Diego, State of California.

Section 3. That Sections 1240.010, 1240.110, 1240.120, 1240.420, 1240.610 and 1255.410 of the California Code of Civil Procedure; Section 220, Charter of City of San Diego; Sections 37350.5 and 40404 of the Government Code and Sections 4090, 5101, 5102, 5023 and 5023.1 of the Streets and Highways Code; inter alia, permit the acquisitions referenced herein.

Section 4. That the parcels of real property and the interests sought to be condemned are described and set forth in Exhibit "A" attached hereto and made a part hereof.

Section 5. That the taking and acquiring by the City of San Diego of the real property herein described is deemed necessary for the construction, operation and maintenance of a public

Section 8. That the City Attorney of The City of San Diego or his designated representative be, and hereby is authorized and directed to commence an action in the Superior Court of the State of California, in and for the County of San Diego, in the name

and on behalf of The City of San Diego, against all owners and claimants to an interest in the above-described real property, for the purpose of condemning and acquiring the certain real property and existing improvements as hereinbefore described in fee simple and easements, for the use of the City of San Diego and to take immediate possession thereof.


