BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the provisions of sections 54.0201 through 54.0206 of the San Diego Municipal Code, and after a public hearing, this Council hereby confirms the cost of weed abatement against tax assessors parcel numbers 577-280-01 and 577-321-01 at \$4,469.00, to be apportioned against each parcel as \$2,234.50 each.


BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized to waive the City's administrative fee of \$1,809.95.
