
WHEREAS, on June 23, 1988, the Planning Commission of The City of San Diego conducted a public hearing and considered and recommended approval of the Mid-City Community Plan Amendment, Area E; and

WHEREAS, the proposed Mid-City Community Plan Amendment, Area E, would redesignate a section of the Oak Park neighborhood, east of Euclid Avenue and north of the split with 54th Street, from low density residential to open space; and

WHEREAS, the proposed Mid-City Community Plan Amendment, Area E, would limit the development intensity to preserve a canyon area in order to assist in implementing open space goals and objectives of the Mid-City Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the Mid-City Community Plan Amendment, Area E, a copy of which is on file in the office of the City Clerk as Document No. RR- 272200, and as described in Planning Report No. 88-400, dated October 18, 1988.
