
ADOPTED ON OCT 31 1988

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$58,000 from Fiscal Year 1989 Park and Recreation Department, Open Space Division, California Conservation Crew Program, Dept. 446, Org. 246, Account 4227, Job Order 044647, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above sponsor agreement and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
