
ADOPTED ON NOV 07 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of September 12, 1988, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 272270, granting to said City easements for public street purposes in portions of Section 22, Township 14 South, Range 2 West, San Bernardino Meridian, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named SPRINGHURST DRIVE, MOUNTAIN PASS ROAD, BRIARLEAF WAY, DAPPLE COURT, DAPPLE WAY and ALPINE TERRACE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
