BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of easement deeds of PARDEE CONSTRUCTION COMPANY, a California corporation, bearing dates of June 30, 1988, and September 20, 1988, and of MARY A. VAN DAM and EDWARD F. VAN DAM and WALTER L. VAN DAM, bearing date of June 12, 1988, all executed in favor of The City of San Diego, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR- 272274-1, RR- 272274-2, RR- 272274-3 and RR- 272274-4, granting to said City easements for public streets, pedestrian and non-motor vehicular right-of-way, as more particularly described in the deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets and pedestrian and non-motor vehicular right-of-way, and the public streets are hereby named SPRINGBROOK DRIVE, SPRINGHURST DRIVE, WICKERBAY COVE, SABRE SPRINGS PARKWAY.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
