- 2. That the City Auditor and Comptroller is hereby authorized to transfer \$313,981.84 from Proposition A 1/2% sales tax Fund 30300, CIP No. 52-313 WHITTIER STREET to CIP No. 11-226 MISSION BEACH DRAIN.
- 3. That the City Auditor and Comptroller is hereby authorized to transfer \$313,981.84 from Capital Outlay Fund 30245, CIP No. 11-226 MISSION BEACH DRAIN to CIP No. 53-032 SORRENTO VALLEY BOULEVARD BRIDGE OVER SOLEDAD CREEK.
- 4. That the expenditure, not to exceed \$313,981.84 from CIP No. 53-032 SORRENTO VALLEY BOULEVARD BRIDGE OVER SOLEDAD CREEK to supplement funds previously authorized by Resolution No. 271256, adopted on June 27, 1988, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
