APPROVING MAP OF DE LA FUENTE BUSINESS
PARK-UNIT 3.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Samuel F. Safino, Registered Civil Engineer, entitled "DE LA FUENTE BUSINESS PARK-UNIT 3 being a subdivision of a portion of the south one-half of Section 35, Township 18 South, Range 1 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to United States Government Survey, approved September 11, 1879, together with a portion of Siempre Viva Road as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Avenida Costa Este, Avenida Costa Sur, a portion of Avenida De La Fuente and a portion of Siempre Viva Road, and said streets and portions of public streets are hereby declared to be public streets and portions of public streets, and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the
