
WHEREAS, it is the intention of the Council of The City of San Diego, that pending the completion of the SANDAG Airport Systems Plan update, or the passage of twelve months, whichever first occurs, that there be imposed a moratorium on granting any approval for development proposed adjacent to Brown Field in The City of San Diego in the general area east of Interstate Highway 805, north of the proposed SR 117 alignment, and to the west and south of the City limits, as shown with particularity on the drawing attached hereto as Exhibit A; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Manager, the Planning Director and the City Attorney are directed to prepare the documents necessary to implement this resolution and expeditiously present them to this Council for their consideration and adoption.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that SANDAG is hereby requested to expedite the work on the Regional Airport Alternative Evaluation phase of the SANDAG Airport Systems Plan update in order to establish as soon as possible the viability of Brown Field as a regional airport site.

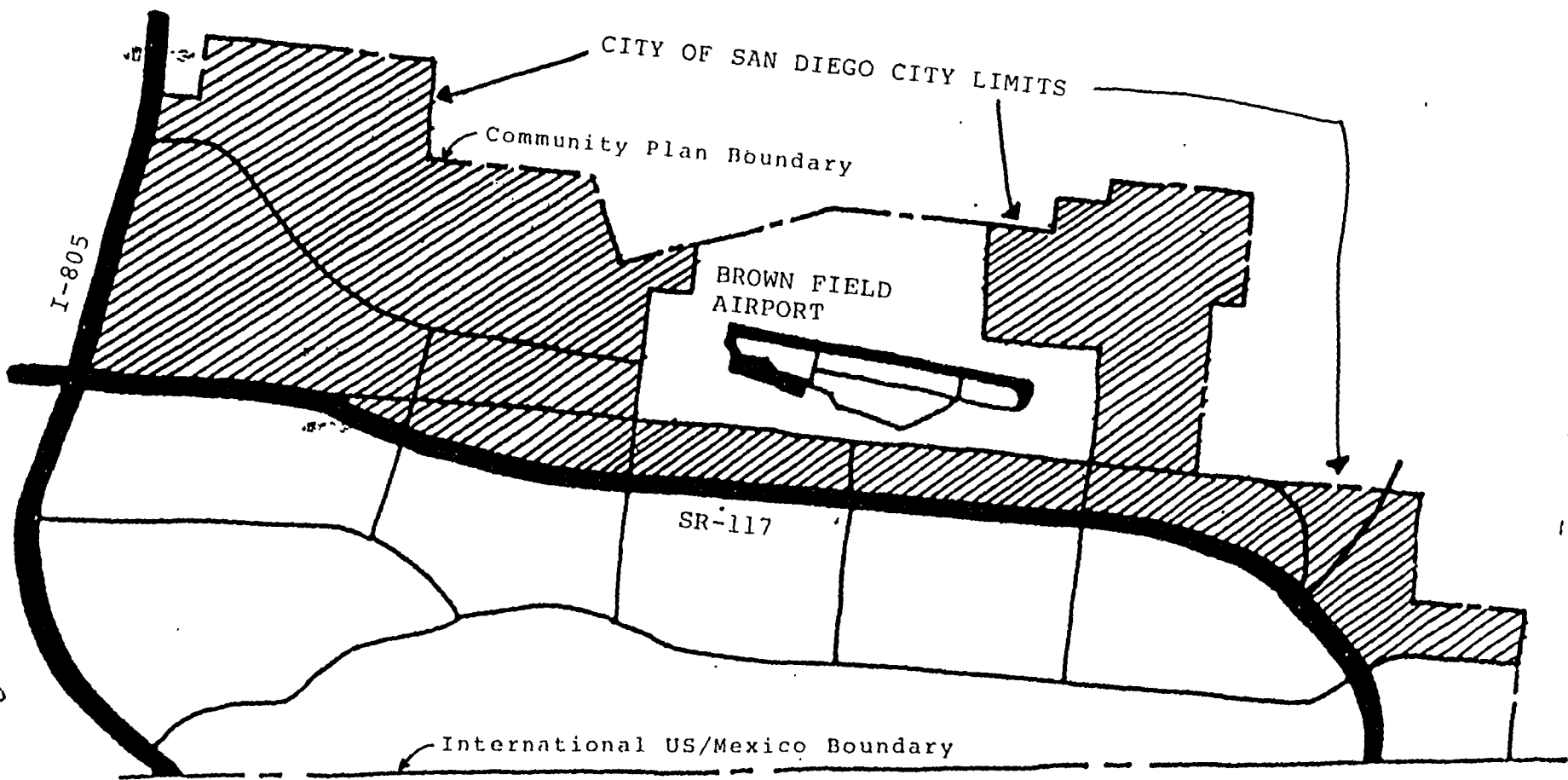
