BE IT FURTHER RESOLVED, that the expenditure schedule for the City's participation in the above project is hereby approved as follows:

\$10,000 for the year 1989 \$15,000 for the year 1990 \$10,000 for the year 1991 and \$10,000 for the year 1992.
