RESOLUTION NUMBER R-272300

ADOPTED ON NOVEMBER 1, 1988

WHEREAS, on June 2, 1988, the Planning Commission of The City of San Diego held a public hearing to consider the request to initiate an amendment to the University Community Plan; and

WHEREAS, following public testimony and Planning Commission review of said request to initiate a plan amendment, the Planning Commission was deemed to have denied the initiation of the amendment due to a lack of four affirmative votes; and


WHEREAS, the Council of The City of San Diego held a public hearing to consider said proposed initiation of the plan amendment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this City Council hereby approves the proposed initiation of an amendment to the University Community Plan to redesignate an 8.57-acre site to allow 30-45 dwelling units per acre and to add 163 units to the Development Intensity Element for certain property located on the east side of Genesee Avenue between Campus Point Drive and Fez Street within the University Community Plan area.

BE IT FURTHER RESOLVED, that the approval of the initiation of the amendment does not constitute approval or denial of the proposed amendment.
