

RESOLUTION NUMBER R- 272301

ADOPTED ON NOV 10 1988

WHEREAS, the Mayor's Committee Against Drug Abuse developed a series of recommendations to address the problems of substance abuse and drug trafficking within the City; and

WHEREAS, the recommendations are the result of the Committee's fifteen month study of the problem, and they are structured to address education, treatment and enforcement; and

WHEREAS, subsequently the City Manager's office facilitated a series of meetings to develop responses to implement the Committee's recommendations and participants include representatives from the Police Department, Community Services, the City Attorney, Intergovernmental Relations and the Mayor's office; and

WHEREAS, the recommendations are set forth in detail and specificity in the many matters discussed as part of City Manager Report No. 88-443 (Revised), dated November 1, 1988; and

WHEREAS, one of the recommendations (2.1) is to establish a San Diego Substance Abuse Commitment (SANDSAC) Committee and appoint members thereto; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to section 43(b) of the Charter of The City of San Diego, there is hereby created The San Diego Substance Abuse Commitment (SANDSAC) Committee, for the purpose of monitoring and coordinating the City Council's implementation of and provide

accountability for the recommendations of the Mayor's Committee Against Drug Abuse.

BE IT FURTHER RESOLVED, that the following appointments by the Mayor of The City of San Diego to serve as members of the San Diego Substance Abuse Commitment (SANDSAC) Committee, pursuant to section 43(b) of the City Charter, be and the same are hereby confirmed:
