WHEREAS, renewed interest locally in the study of geography has been recently noted by the San Diego Union; and

WHEREAS, the Department of Geography at San Diego State
University has planned a celebration of National Geography
Awareness Week; and

WHEREAS, it is important that the elected officials of San Diego County assume a significant role in raising the public's geographic awareness; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does hereby endorse the congressional resolution designating the period of November 13-19, 1988 as "NATIONAL GEOGRAPHY AWARENESS WEEK."
