BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for REPLACEMENT OF ARGOS DRIVE STORM DRAIN, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on NOV 14 1988, and bearing official Document No. W.D. 122419, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for REPLACEMENT OF ARGOS DRIVE STORM DRAIN.

BE IT FURTHER RESOLVED, that the City Manager and the City Auditor and Comptroller are directed and they are hereby authorized to add CIP No. 11-243 ARGOS DRIVE STORM DRAIN REPLACEMENT as a CIP project to the Fiscal Year 1989 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$52,670.94 (\$31,390.01 from Capital Outlay Fund 30245, CIP No. 11-240 BALMORAL DRIVE STORM DRAIN, and \$21,280.93 from Capital Outlay Fund 30245, CIP No. 12-055 UNIVERSITY AVENUE DRAIN) to CIP No. 11-243 ARGOS DRIVE STORM DRAIN REPLACEMENT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$52,670.94 from Capital Outlay Fund 30245, CIP No. 11-243 ARGOS DRIVE STORM DRAIN REPLACEMENT is hereby authorized solely and exclusively for providing funds for said project and related costs.
