APPROVING PARCEL MAP T.M. NO. 83-0787.


BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Sydney S. Xinos, Registered Civil Engineer, entitled "PARCEL MAP T.M. NO. 83-0787 being a division of Lot 1 of Hammond subdivision, in the City of San Diego, County of San Diego, State of California, according to map thereof, No. 4207, filed in the office of the County Recorder of San Diego County of June 3, 1959," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication that portion of Parcel 1 marked "Reserved for Future Streets," as shown on this map, under the provisions of Section 66440 of the Government Code.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council and that said Council has approved said parcel map; that said Council has rejected a portion of Parcel 1, marked "Reserved for Future Street;" all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
