

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a Director's Deed of the STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION, executed in favor of The City of San Diego, the form of which is on file in the office of the City Clerk as Document No. RR-272318, conveying to said City a 4,115-square-foot parcel of vacant land consisting of portions of Lots 37 and 38, Block A of the Resubdivision of Villa Lots 1 through 11, inclusive, of Normal Heights, Map No. 1155 filed December 10, 1908, as more particularly described in the deed, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$35,000 from C.I.P. 29-566, Mid-City Park Site - Acquisition, Fund 18524, Dept. 5663, Org. 6303, to cover the cost of acquisition and related costs for the above site, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
