ERIE BAPTIST CHURCH all that portion of Lots 1 through 6, Block 4, Homedale, as more particularly described in said grant deed.
- 3. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.

BE IT FURTHER RESOLVED, that Resolution R-269435, adopted October 12, 1987, previously approving the sale of the above described property to Mt. Erie Baptist Church under different terms, is hereby rescinded.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver the deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
