
ADOPTED ON NOV 14 1988

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$77,224 from Penasquitos Park Development Fund No. 39085, CIP No. 29-644, Canyonside Community Park - Additional Ballfields, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above first amendment to agreement and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
