A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING A \$10,000 ADVANCE AGAINST EXPENSES FROM THE SAN DIEGO STATE UNIVERSITY FOUNDATION AND TRANSFERRING \$10,000 TO THE REDEVELOPMENT AGENCY.

WHEREAS, the San Diego State University Foundation has requested The City of San Diego, via the Planning Commission, to establish a Redevelopment Survey Area; and

WHEREAS, the Planning Commission has recommended and the Council of The City of San Diego has established said Survey Area; and

WHEREAS, the San Diego State University Foundation has held the City harmless for the expenses to be incurred in the redevelopment process for the San Diego State University Foundation Redevelopment Project; and

WHEREAS, the San Diego State University Foundation has offered \$10,000 as an advance payment against expenses; and

WHEREAS, the City is desirous of determining the feasibility and desirability of establishing a redevelopment project; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Council hereby accepts the advance payment of \$10,000 from the San Diego State University Foundation.

2. The Council hereby transfers \$10,000 to the Redevelopment Agency of The City of San Diego to cover staff expenses.
